## 13. General Manager Comments (taken out of order)

General Manager Chris Theisen announced his planned resignation/retirement from VRSD to take place in early 2025 so as to give time for the Board to start and complete the process of finding his replacement. He then recommended that the Board direct the Executive Committee to initiate the process of searching for his replacement.

# 12. <u>Board Member Comments and Future Agenda Items</u>

The Board discussed the process of contracting with an executive search firm for the General Manager recruitment. The Board delegated the process of choosing a search firm to the Executive Committee, but it was noted that the Board would need to approve a contract for a search firm following the Committee's recommendation. The selected firm may be asked to perform a salary survey in addition to finding qualified candidates for the Board to interview.

In response to a question from Director Perello (Oxnard), Mr. Theisen asked Mr. Jones to update the board on the latest information regarding the Oxnard Golf Course (i.e., closed Coastal and Santa Clara Landfills) issues with the Los Angeles Regional Water Quality Control Board. Richard Jones, Director of Operations, reported that the consultant dug over 400 holes to check the landfill cover depth and found that the cover was intact with no problems noted. Cover was needed to be increased in some areas and it was determined that the observed trash was from windblown trash only and not from any exposed area on the landfill. Oxnard officials were told to replace wood chips in certain areas with plantings because wood chips allow more water to penetrate the ground. The post closure plan will be updated.

A report on the payment collection for the damage to the Toland Landfill gate was given by Director of Finance, Tina Rivera. She reported that the responsible company has been paying and has a balance of about \$6,000 which they intend to pay in full.
